

**TOWN OF BREMEN
SELECTMEN'S MEETING MINUTES
VIA ZOOM AND IN-PERSON
November 21, 2024, at 5:00 p.m.**

The meeting was called to order at 2:05 p.m.

On a motion duly made by Selectman Page and seconded by Selectman Marsh, the Board of Selectmen voted to appoint Tom Durkee as Bremen Code Enforcement/Local Plumbing/Shoreland Zone Officer. 3-0

The date of December 11, 2024 at 4:00 pm has been determined for the abatement hearing/meeting.

On a motion duly made by Selectman Marsh and seconded by Selectman Page, the Board of Selectmen voted to approve the amendment to extend the NDEC/Tidewater/Town of Bremen subsidy program. 3-0

On a motion duly made by Chairperson Pieh and seconded by Selectman Page, the Board of Selectmen voted to donate \$200.00 to the Bremen Fire Department for the Christmas Party. 3-0

Bruce Poland, Fire Chief, presented the information on a 2022 Ford F-350 diesel truck that the Department/First Responders would like to purchase as the new rescue vehicle. This truck has 18K miles and Darlings will remove the existing body and replace with the utility body. The total cost of the vehicle is \$59,800. The previous meeting minutes outlined the cost breakdown as to which account funding would be from.

On a motion duly made by Selectman Marsh and seconded by Selectman Page, the Board of Selectmen voted (3-0) to approve the purchase of the 2022 Ford F-350.

Ann Nesslage, Conservation Commission, discussed the items from the previous BCC meeting. The Commission honored the late Virginia Betts at the meeting, further discussion of the mowing and that the field mowing had been completed. The garbage can and the porta potty have been removed from the Hay Property. The Commission also discussed the possible addition of picnic table at Hilton O'Connor.


On a motion duly made by Chairperson Pieh and seconded by Selectman Marsh, the Board of Selectmen voted (3-0) to approve the Minutes of 11-07-2024.

On a motion duly made by Chairperson Pieh and seconded by Selectman Page, the Board of Selectmen voted (3-0) to approve, the Warrant of 11-22-2024.


On a motion duly made by Selectman Page and seconded by Chairperson Pieh the Board of Selectmen voted (3-0) to go into executive session pursuant 36 MRS 841(2) AND MRS 405(6)(F).
